GFOA Awards 2024 Scholarships

(Chicago, Illinois – April 26, 2024) Government Finance Officers Association (GFOA) has announced the recipients of its 2024 scholarships. GFOA's mission is to promote excellence in state and local government financial management and the awarding of scholarships is one of the ways GFOA accomplishes its mission.

The recipient of the \$25,000 Goldberg-Miller Public Finance Scholarship is Rachel Eddings.

 Rachel Eddings is the finance officer for the Town of Montreat in Western North Carolina. Originally from the Ohio-Michigan area, Rachel has called Black Mountain, North Carolina, home for the last 22 years. She has always focused on being the best employee by continuing her education and learning everything she could from each position. She recently enrolled in the Master of Public Administration program at Montreat College.

The recipients of the two awards for the *Frank L. Greathouse Government Accounting Scholarship* are **Kanika Jain** and **Aaron Keathley-Silva.** Each will receive \$10,000.

- Kanika Jain holds a bachelor's degree in business administration with a
 concentration in Accounting from the University of California, Riverside, and is
 currently pursuing a master's degree in accountancy at California State
