THE SMALL GOVERNMENT FORUM

allows members of small governments to network and exchange information about topics that are unique to managing a small government. The forum, which was created in 2015, is open to GFOA members in small jurisdictions from the United States and Canada—those with populations of 25,000 or less, or with employee counts of 500 or less.
