# **UNDERSTANDING THE COMPLIANCE LANDSCAPE**

The regulatory framework governing federal grants is designed to ensure that funds are used effectively, efficiently, and in compliance with federal laws and regulations. In addition, the Federal Register serves as a key resource for updates and changes to grant-related regulations and policies, such as new guidance for grants and agreements, which stakeholders must stay informed about to maintain compliance.

The five main areas of focus are financial management, internal controls, cost principles, procurement, and audit requirements.

### Financial management

Financial management compliance pertains to the accurate and timely management of funds.

This may encompass:

- · Keeping detailed, organized, and accurate financial records.
- Implementing procedures for tracking, reconciling, and auditing transactions.
- Establishing budget controls to prevent overspending or misallocation of funds.
- Submitting timely and accurate financial reports.

### **Internal controls**

Internal controls are processes and procedures that ensure the integrity of financial and accounting information, promote accountability, and prevent fraud. These may include:

- Segregation of duties to avoid conflicts of interest.

### Cost principles

- Whether specific costs are allowable (some costs may be explicitly not allowable under certain circumstances).

### **Procurement**

Procurement compliance refers to the regulations governing the purchase of goods and services with federal grant funds. This can involve:

- Following competitive bidding procedures.
- Avoiding potential conflicts of interest.
- Keeping detailed records of procurement processes.

### **Audit requirements**

Audit requirements dictate how and when an organization's use of federal grant money is examinable. These requirements may include:

- Regular audits to ensure compliance with financial management, internal control, cost principle, and procurement standards.
- Prompt resolution of audit findings (discrepancies and violations identified during an audit).
- Adherence to Single Audit Act (for entities that expend \$750,000 or more of federal funds in a year).
