GFOA's membership network includes many individuals who exemplify the role of public servant, working to support others, lead organizations through both good times and bad, and make a positive impact on those they serve.

Lake Akinkugbe

Director of Finance, AlexRenew, Virginia



Akinkugbe has made a significant impact on the wastewater treatment authority in just over a year, promoting transpar-

ency and simplifying complex reports. Accounting Manager Jason Moore at AlexRenew (who nominated Akinkugbe) said, "I couldn't ask for a better mentor and manager. Lake encourages thought-provoking conversation and listens to any idea that could further our department and organization. He is selfless and encouraging."

Dennis Click

Deputy Controller, County of Albemarle, Virginia



Click is leading the implementation of the county's financial management system, and his expertise in data readiness has

amlined processes. He has refined data structures and fostered collaboration with vendors and stakeholders to keep the project ahead of schedule. Controller Jian Lin (who nominated Click) called him "a role model with his broad financial knowledge, technical skillset, and his leadership."

Town Comptroller, Town of Eastchester, New York

Chief Deputy Treasurer, Pinal County, Arizona



Munroe's experience across various sectors enables her to bridge departments and streamline procedures, creating a

proactive approach to efficiency. In addition, her open-door policy and commitment to staff development fosters a positive work environment. honor by Carrie Marckess, assistant finance director for the Village of Bloomingdale, Illinois; and Courtney Kouzmanoff, budget officer for the City of Champaign, Illinois. Kouzmanoff said, "Molly's mentoring mindset, characterized by her willingness to provide guidance and support, is truly admirable." Marckess credits Molly's encouragement for inspiring her to pursue GFOA's CPFO designation and a master's program.

Marcia Tannian

Director of Finance and Investor Relations, New York Metropolitan Transportation Authority, New York

Tannian oversees MTA's annual debt issuance, manages its debt portfolio, ensures that the agency's disclosure is thorough, accessible, and well-presented, and develops financing plan strategy and the structure of bond issuancesearning MTA recognition for exemplary disclosure practices. Steve Webb

Finance Director, City of Covington, Kentucky



Webb developed a financing plan for the city's investment portfolio, debt structure, capital needs, and declining

revenues. As City of Covington Budget Director Joel Baker (who nominated Webb) notes, "Steve is a natural leader." Under Webb's guidance, the city achieved a clean audit with no findings in FY23, the first since FY96. Steve has also increased collections and boosted income while improving income.

Darlene Wildes

Deputy Auditor, City of Columbus, Ohio, Auditor's Office



Under Wildes' leadership, Columbus became the largest city in the country to maintain AAA/Aaa/ AAA credit ratings. As

City Auditor Megan Kilgore (who nominated her) said, "The citizens of Columbus likely do not know the name Darlene Wildes, but they have most certainly benefited from her 28 years with the city." Darlene has modernized systems, created a Transparency Portal that makes information accessible to the public, and started AI initiatives.

Nancy Young-Oliver

Chief Financial Officer, TriMet, Oregon



Young-Oliver has played a pivotal role in achieving the district's AAA bond rating, leading initiatives including

an energy credit program and the first fare increase in nearly a decade. Young-Oliver is also committed to fostering talent. Michael Dohn, Budget and Forecasting Director at TriMet (who nominated Young-Oliver), said, "Although I am the one submitting this nomination, there is a long line of colleagues behind me endorsing it."

All GFOA members are eligible to be recognized with this program or nominate someone who has made a difference, exemplified the values in GFOA's code of ethics, or served as a role model for the public finance profession. Nominations for 2025 will open in January 2025. 🖪
